

2018 RRRoll Up at Home! Contest ("Contest")

Official Contest Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY MAY BE REQUIRED. THIS CONTEST IS INTENDED FOR VIEWING AND PARTICIPATION IN CANADA ONLY AND WILL BE GOVERNED BY CANADIAN LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE.

A valid e-mail address is required to participate in the Contest.

Contest Period:

The Contest entry period opens on February 7, 2018 at 12:00:01 a.m. Eastern Time (ET) and closes on March 25, 2018 at 11:59:59 p.m. ET (the "Contest Period"). However, Eligible Purchases (defined below) must be completed between February 7, 2018 at 12:00:01 a.m. Eastern Time (ET) and March 18, 2018 at 11:59:59 p.m. ET (the "Transaction Period") and Mail-in Requests (defined below) must also be submitted during the Transaction Period (as described in greater detail below).

Eligibility:

The Contest is open to all residents of Canada who: (i) have reached the age of majority within their province/territory of residence at the time of registration; or (ii) are thirteen (13) years of age or older at the time of registration, but under the age of majority within their province/territory of residence (each, a "Minor"), provided they have their parent or legal guardian's agreement that both of them shall be bound by these Official Contest Rules (the "Rules"). To be eligible to claim a prize, claimant must have reached the age of majority within his/her province/territory of residence and have a valid email address. If a potential winner is a Minor, his/her parent or legal guardian must complete the prize claim process (see below for details) and the applicable prize will only be awarded to such Minor's parent or legal guardian (subject to compliance with these Rules). Despite the foregoing, employees, representatives or agents of (and any person domiciled with any such employee, representative or agent) Tim Hortons Advertising and Promotion Fund (Canada) Inc. (the "Sponsor"), The TDL Group Corp., Inmar Promotions – Canada Inc. (the "Administrator"), their respective parent, affiliated and related companies, Tim Hortons franchisees/licensees, the consulting, advertising and promotion agencies of the Sponsor and/or the independent contest organization (collectively, the "Contest Parties") are not eligible to enter the Contest. Employees, representative or agents of Tim Hortons franchisees/licensees as described in this paragraph include employees, representatives or agents who are providing services in any way to a Tim Hortons restaurant(s) (as determined by the Sponsor in its sole and absolute discretion).

NOTE TO MINORS: The Sponsor reserves the right, in its sole and absolute discretion, on a random audit basis or at any time and for any reason, to contact a Minor's parent/legal guardian for the purposes of verifying his/her: (i) agreement to be legally bound by these Rules on the Minor's behalf; (ii) consent to the Minor's participation in this Contest; and/or (iii) consent to the collection of the Minor's personal information. Failure of a Minor's parent/legal guardian to complete any such required verification to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may, in the sole and absolute discretion of the Sponsor, result in disqualification of the applicable Minor.

How to Register & Enter:

NO PURCHASE NECESSARY. To enter the Contest, visit www.rollupathome.com and perform the following steps during the Contest Period:

1. Follow the on-screen instructions to fully complete the registration form (the "Registration Form")

with all of the required information, which includes a requirement to: (i) enter your name, complete mailing address, telephone number (including area code), e-mail address and create a password (supplying your date of birth and salutation are optional); and (ii) signify your agreement that you (and, if you are a Minor, your parent or legal guardian) have read and agree to be legally bound by the terms and conditions of these Rules.

2. Upon successfully registering, you follow the on-screen instructions to upload an image of a Receipt (defined below) (an "Upload"). In terms of an Upload of a Purchase Receipt (defined below), it must evidence that an Eligible Purchase was completed in a clear and legible format (as determined by the Sponsor in its sole and absolute discretion), including without limitation the following information: (i) the Participating Retailer's (defined below) name and mailing address; (ii) the unique receipt code (if applicable); (iii) the purchase time and date; and (iv) an Eligible Product (defined below) purchase.
3. Upon successfully completing an Upload, a RRRoll Up At Home Game Screen will appear and you must follow the on-screen instructions to click on the Tim Hortons bag of coffee (a "Click"). There is a limit of one (1) Click per Upload, regardless of the number of Eligible Products listed on the applicable Receipt.
4. Upon successfully completing a Click, you will: (a) receive one (1) entry into the Grand Prize Draw (defined below) (each, an "Entry"); and (b) will be notified on-screen if you are a potential Secondary Prize winner.

There are two (2) ways to receive a Receipt, as follows:

- A. Eligible Purchase: If you purchase an eligible product listed in Schedule "A" (each, an "Eligible Product") from an authorized Tim Hortons product retailer or restaurant in Canada (each, a "Participating Retailer") during the Transaction Period (collectively, an "Eligible Purchase") retain your original receipt that evidences that you made an Eligible Purchase (each, a "Purchase Receipt").
- B. Mail-in Request: To receive a receipt (each, a "Mail-in Receipt" and, together with Purchase Receipts, "Receipts") without having to make an Eligible Purchase, handwrite your name and full mailing address on a 5"x3" piece of white paper and mail it, along with a **return self-addressed stamped (i.e. postage paid) envelope** to: Tim Hortons *RRRoll Up at Home!* Contest, PO Box 13432, Saint John, NB E2L 5E7 (collectively, a "Mail-in Request"). In order to be eligible, a Mail-in Request must be post-marked during the Transaction Period and received by March 18, 2018. Limit one (1) Mail-in Request per outer mailing envelope (e.g. mass Mail-in Requests in the same envelope will be void). Further, Mail-in Requests that are mechanically reproduced or made in any fashion other than as specified herein are void. Upon receipt of an eligible Mail-in Request (as determined by the Sponsor in its sole and absolute discretion), you will be sent a Mail-in Receipt (using the return self-addressed stamped envelope provided).

Limit of one (1) registration per person /email address. Limit of one (1) Upload per Receipt. Limit of one (1) Click per Upload. Each Receipt can only be submitted one (1) time in the Contest. Each Receipt will automatically be void after its first Upload or at the end of the Contest Period (whichever occurs first). Please retain your original Receipt for your records. All Receipts submitted are subject to verification in the sole and absolute discretion of the Sponsor. Any Receipt that cannot be verified as compliant with the letter and spirit of these Rules to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor, is subject to immediate disqualification (in which case any Entry received in connection with such Receipt will be declared null and void and any rights to any Prize associated with such Receipt will be forfeited).

Prizes:

There is a total of 10,022 prizes ("Prizes") available to be won at the outset of the Contest. Of these Prizes, twenty-two (22) are grand prizes (the "Grand Prizes") and the remaining 10,000 are secondary

prizes (the “Secondary Prizes”).

Grand Prizes: There are two (2) types of Grand Prizes, as follows:

1. 2018 Honda Civic: Two (2) of the Grand Prizes each consists of one (1) 2018 Honda Civic EX-T vehicle (each, a “2018 Honda Civic Grand Prize”). The approximate retail value of each 2018 Honda Civic Grand Prize is \$25,390.00 CAD before any applicable taxes, freight & P.D.I.
2. Tim Hortons® Free Coffee For A Year: Twenty (20) of the Grand Prizes each consists of one (1) Tim Hortons FREE Coffee for A Year prize. (each, a “Tim Hortons Coffee for A Year Grand Prize”). Prize will be awarded as a Tim Hortons® Free Coffee For A Year Tim Card® (a physical card) which allows the winner to receive one (1) of the following beverages: any size hot beverage, any size Iced Capp®, any size Iced Coffee, or any size Iced Latte (each, a “Daily Free Coffee Prize”) each day during the Coffee For A Year Activation Period (defined below). Latte and Iced Latte subject to available sizing. **Each Daily Free Coffee Prize is available and may only be redeemed once, and becomes void at 11:59:59 pm each day (based on local time at place of redemption). If a winner does not redeem his/her Daily Free Coffee Prize on a particular day, that Daily Free Coffee Prize becomes void and may not be carried over to or combined with a Daily Free Coffee Prize redemption for another day.** Each Tim Hortons® Free Coffee For A Year Tim Card® must be activated by the applicable winner no later than July 1, 2018, and is valid for 365 consecutive days commencing on the day the card is activated by the applicable winner, or until June 30, 2019, whichever occurs sooner (the “Coffee For A Year Activation Period”). There is a limit of 365 Daily Free Coffee Prizes per Tim Hortons® Free Coffee For A Year prize, which would only be possible if the applicable winner redeemed his/her Daily Free Coffee Prize on each day of the Coffee For A Year Activation Period. Tim Hortons® Free Coffee For A Year Tim Card® will be issued once only. Sponsor is not responsible for lost, stolen or damaged Tim Hortons® Free Coffee For A Year Tim Card®. Prize once awarded shall be the sole responsibility of the winner. The approximate retail value of each Tim Hortons Coffee for A Year Grand Prize is \$617.

Limit of one (1) Grand Prize per person/email address.

Secondary Prizes: There are three (3) types of Secondary Prizes, as follows:

1. \$50.00 Tim Card®: Fifty (50) of the Secondary Prizes each consists of an electronic \$50.00 Tim Card (each, a “\$50 Tim Card Prize”).
2. \$10.00 Tim Card®: Five hundred (500) of the Secondary Prizes each consists of an electronic \$10.00 Tim Card (each, a “\$10 Tim Card Prize”).
3. \$5.00 Tim Card®: Nine thousand four hundred fifty (9,450) of the Secondary Prizes each consists of an electronic \$5.00 Tim Card (each, a “\$5 Tim Card Prize”).

Each 2018 Honda Civic Grand Prize will not be released unless and until the confirmed Prize winner first shows proof (in a form acceptable to the Sponsor) of having a valid driver’s license (equivalent to a full “G” class license in Ontario) in the province/territory in which he/she resides and proof (in a form acceptable to the Sponsor) of satisfactory insurance. Total approximate value of all prizes: \$117,870.00 CAD.

Secondary Prize Winner Selection & Notification

Each of the Secondary Prizes will be assigned a random, computer-generated time stamp that corresponds to a date and time during the Contest Period. The entrant that performs a Click on or immediately after the predetermined time-stamp associated with a Secondary Prize (as determined by the Sponsor in its sole discretion on the basis of its records) will be the potential winner of such Secondary Prize. The odds of winning a Secondary Prize depend upon the timing and order of Clicks during the Contest Period. The number of Secondary Prizes available to be won will decrease throughout the Contest Period as they are claimed. If you are deemed to be a potential Secondary Prize winner, then you will be instantly notified on-screen and you must comply with the on-screen instructions to complete the winner confirmation process (details below), failing which you may, in the sole and absolute discretion of the Sponsor, be disqualified (and, if disqualified, you will forfeit all rights to the applicable Secondary Prize).

Grand Prize Winner Selection & Notification

On March 30, 2018 (the "Draw Date") at 1:00 p.m. ET in Saint John, NB the Sponsor will conduct one (1) random draw (the "Grand Prize Draw") from among all Entries received during the Contest Period, and:

1. the first two (2) entrants drawn will each be deemed a potential 2018 Honda Civic Grand Prize winner; and
2. the next twenty (20) entrants drawn will each be deemed a potential Tim Hortons Coffee for a Year Grand Prize winner.

Secondary Prize Winner Confirmation

Verification:

If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) use multiple names, identities, accounts, email addresses and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or disrupt this Contest; (ii) falsely submit a Receipt without obtaining it in accordance with the letter and spirit of these Rules; (iii) re-submit a Receipt a subsequent time after its first submission; and/or (iv) submit a Receipt that has been falsified, manipulated or otherwise altered in any way (all as determined by Sponsor in its sole and absolute discretion); then he/she may be disqualified from the Contest in the sole and absolute discretion of the Sponsor. All Entries, registrations, Clicks, Mail-in Requests, Receipts, Eligible Purchases and any other type of information in any way connected to this Contest (collectively, "Contest-related Information") and entrants are subject to verification at any time and for any reason. The Sponsor reserve its right, in its sole and absolute discretion, to require proof of identity, eligibility and/or compliance with these Rules (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purpose of verifying an individual's eligibility to participate in this Contest; (ii) for the purpose of verifying the eligibility and/or compliance of any Contest-related Information submitted (or purportedly submitted) with these Rules; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purpose of administering this Contest in accordance with the letter and spirit of these Rules. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may result in disqualification in the sole and absolute discretion of the Sponsor. The sole determinant of the time for the purposes of this Contest will be the Contest server machine(s). The Released Parties are not responsible for any lost, late, incomplete, invalid, unintelligible or misdirected Contest-related Information, which will be disqualified. In the event of a dispute as to who has submitted any given registration, the authorized account holder of the email address used to register will be deemed to be the registrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. A potential winner may be required to show proof of being the applicable authorized account holder associated with the registration in question. Without limiting the generality of the foregoing, a Registration Form may be rejected if (in the sole and absolute discretion of the Sponsor) it is not fully completed with all required information and received during the Contest Period. All personal and other information requested by and supplied to Sponsor for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Sponsor reserves the right, in its sole discretion; to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information (as determined by the Sponsor in its sole and absolute discretion).

General Rules:

The approximate retail values for the Grand Prizes (set for above) are based on approximate prize values in Canada at the time of printing of these Rules. All such approximate retail values do not include applicable taxes, and any taxes due will have to be paid by winners.

All Contest-related Information becomes the property of the Sponsor. Any attempt to deliberately damage any website or to undermine the legitimate operation of this Contest in any way (as determined by Sponsor in its sole and absolute discretion) is a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law. The Sponsor, with the consent of the Régie, reserves the right to cancel, amend or suspend this Contest, or to amend these Rules, in any way without prior notice or obligation, in the event of any accident, printing, administrative, or other error of any kind, or for any other reason whatsoever. Without limiting the generality of the foregoing, the Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law.

Entrants who choose to participate via a compatible mobile device (which, for greater certainty is optional and not required) are solely responsible for any applicable costs.

By entering the Contest, each entrant (and, if a Minor, his/her parent or legal guardian) agrees to be legally bound, and to abide, by these Rules and the decisions of Sponsor and/or the independent contest organization, which are final in all respects. By entering this Contest, each entrant (and, if a Minor, his/her parent or legal guardian) agrees that the Sponsor can use their name, voice, town, city, province/territory/state of residence, and/or photograph in any publicity or advertisement carried out by Sponsor, without further remuneration or notice, except where prohibited by law.
